The declarant states he knows, accepts and agrees to comply with the "Instructions and requirements for complying with the declaration of responsibility for navigation and flotation in the Ebro basin", which is updated and available at <http://www.chebro.es> or by contacting the Confederation. He additionally declares to do the following:

1. Clean the vessel in accordance with the "Ebro Hydrographic Confederation Cleaning Protocol" (see Appendix 1, 2 and 3 in the instructions).
2. Identify its craft by painting the corresponding licence numbers on both sides, so they are easily visible and legible away from the boat.
3. Be aware that this statement does not lead to a monopoly or preference of any kind in favour of the declarant, and that navigation may temporarily or permanently be suspended by the Confederation for safety, health or other justified reasons, without the declarant being entitled to any compensation.
4. Confirm that its vessels comply with current legislation regarding their stability requirements and safety equipment availability, and the good condition of both.
5. The boats are equipped with the necessary safety and rescue features for the occupants (lifejackets and float vests in bright colours, with sound and light signals ...).
6. Observe the signalling and buoyage in prohibited areas, as well as other conditions and restrictions. Vessels must never come to the reservoir dam or outlet areas, within the distance established for each reservoir (see Appendix 2 in the instructions) or within 400 metres for those without some particular limitation (this same limitation also applies to berthing points).
7. Observe the rules on crossing and range contained in the current navigation code, and in all cases, the Collision Regulations and the Safety Convention on Life at Sea.
8. Observe the navigation rules for mountain rivers and the Najerilla and Piqueras-Iregua rivers listed in Appendix 4 of the "Instructions and requirements for complying with the declaration of responsibility for navigation and flotation in the Ebro basin".
9. Comply with the requirements of the Inland Fisheries Act and, in general, any applicable rules of an industrial, work, administrative or fiscal nature. In reservoirs where fishing is being practised, to keep a minimum distance of 50 metres from the shore during the fishing season.
10. To have all authorisations required for navigation, including those issued by other official organisations.
11. Not to enter stretches of the river and/or navigate during periods prohibited by the Confederation; and not to navigate at night.
12. To have sufficiency of ownership, according to current regulations, to be able to handle the declared vessels or be sufficiently liable for those handling the vessels.
13. Be aware of the inherent hazards of navigation and flotation in inland water, and be committed to controlling the vessel at all times and assume all risks that may result from it. For these purposes, to have an insurance policy **which must be in force during the entire period of the activity declared**.
